

Council Tax

2002-2003 Actual Performance

During the year a total of 922 houses were added to the Council Tax List. 801 (87%) of these were added within 3 months of the date of occupation and 893 (97%) were added within 6 months. The remaining 29(3%) were added more than 6 months from the date of occupation.


2002-2003 Targets

The targets set for the year of 85% within 3 months and 97% within 6 months were achieved.

2003-2004 Targets

The targets for 2003-2004 are: 87% within 3 months and 97% within 6 months.

Valuation Roll:

2002-2003 Actual Performance

During the year 1,134 statutory amendments were made to the Valuation Roll. 608 (54%) of these were made within 3 months of the effective date of the alteration and 898 (79%) were made within 6 months. The remaining 236(21%) were added more than 6 months from the effective date of the alteration.

(During the year the number of entries in the Valuation Roll rose from 11,928 to 11,972 and the total rateable value fell from £193.8M to £190.8M)

2002-2003 Targets

The targets set for the year of 49% within 3 months and 75% within 6 months were achieved.

2003-2004 Targets

The targets set for 2003/2004 are: 55% within 3 months and 79% within 6 months.
